Preferably collected and sent all together by the leader from each national team to avoid delays and missing documents.

Missing tickets and boarding passes or tickets without price on them in EUR (or if the price is in local currency, must be presented by visible purchase date) will not be reimbursed.

FLIGHT OPTIONS

You can search for the flights to Bratislava, Vienna, Budapest or Prague. We recommend www.skyscanner.net

If you arrive to **Bratislava**, you can check connectios to Trnava on ww.cp.sk (bus/train 30-60 minutes, price around 5 eur).

If you arrive to **Vienna** Schwechat airport, you will take a direct bus to Bratislava (duration 1 hour, price 5 eur, companies: Regiojet, Slovaklines or Flixbus) and then from Bratislava to Trnava again you can check connectios on www.cp.sk.

If you arrive to **Budapest** airport, you will take public transport in the city and then either a bus or a train to Bratislava (3 hour, price 15-20 eur). From Bratislava to Trnava you can check connectios on www.cp.sk.

If you arrive to **Prague** airport, you will take public trnasport in the city and then either a bus or a train to Bratislava (5 hour, price 20 euros +). From Bratislava to Trnava you can check connectios on www.cop.sk.

There will be coffee breaks twice a day. Each participants must inform about diets, intolerances upon arrival. The form will be sent to partner organisations and shared with participants

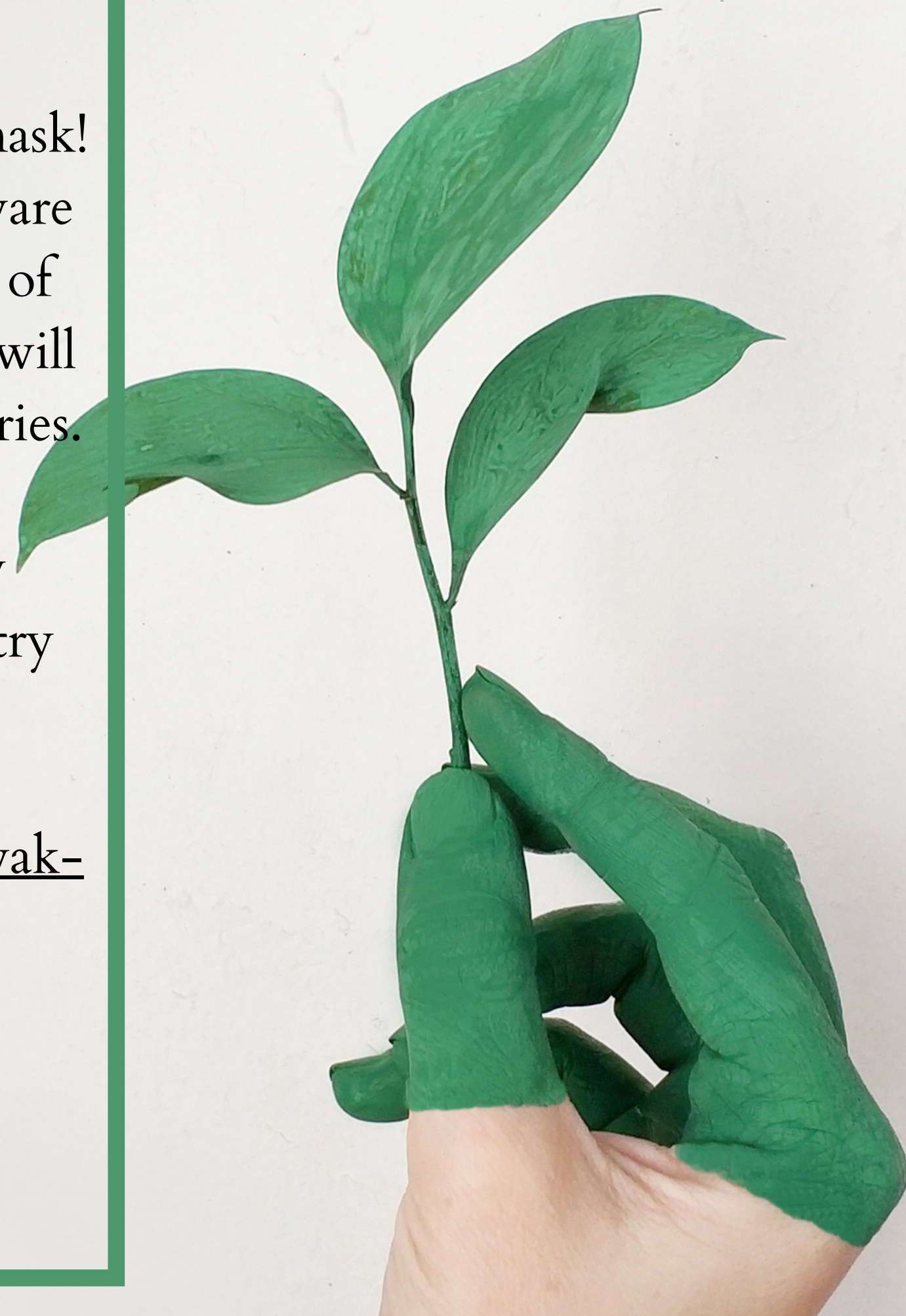
COVID - 19

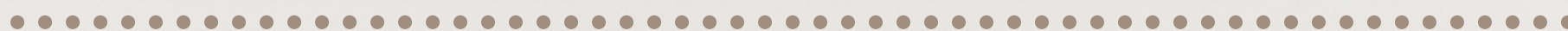
